The Commission proceeded to negotiate the terms and conditions of the contract with the authorized representative of the company **ProQuest LLC**, Eva Czegledi, via conference call.

The authorized representative of **ProQuest LLC**, Eva Czegledi proposed a price for "Subscription for ProQuest's online database *ABI Inform Complete and Ebrary business e-book collection*, with full-length books, articles from scientific magazines, conference materials, dissertations, market research reports" under the terms and conditions of the invitation to the amount of:

- USD 11,490.00 (eleven thousand four hundred and ninety US dollars), equal to BGN 20,503.73 (twenty thousand five hundred and three Bulgarian leva and seventy-three Bulgarian cents [stotinki]), exclusive of value-added tax, as per the exchange rate quoted by the Bulgarian National Bank for 4th February 2016, i.e. BGN 1.74532 / USD 1.00, for a one-year period of use

The Commission announced it was satisfied with the proposal so made concerning the contract price. The Commission decided to accept that proposal.

The Commission proceeded to discuss the remaining terms and conditions under the contract as per the requirements of the contracting authority, the University of National and World Economy, as specified in the invitation to tender.

The authorized representative of **ProQuest LLC**, Eva Czegledi proposed that the condition specified in section VII "Licensor's Obligations", item 4, and namely: "Licensor reserves his right to withdraw, at any time, from the licensed materials any unit or part of a unit which he no longer has the right to publish, or which, in his reasonable opinion, affects any third party's copyrights or any other intellectual property right, or which is libelous, obscene or otherwise undesirable. If such withdrawal comprises more than 10% (ten percent) of the licensed materials, Licensor shall give Licensee a prior written notice of such withdrawal and shall recover within ... days such portion of the Fee that is proportionate to the sum of the withdrawn licensed materials and the remaining non-elapsed portion of the subscription period should be dropped because it is impossible to withdraw any percentage of the licensed materials whatsoever.

The Commission unanimously accepted that the proposal specified in section VII "Licensor's Obligations", item 4 should be dropped.

The authorized representative of **ProQuest LLC**, Eva Czegledi confirmed that she agreed with the terms and conditions of the contract and the appendix thereto.

The Commission proposes that a contract for "Subscription for ProQuest's online database ABI Inform Complete and Ebrary business e-book collection, with full-length books, articles from scientific magazines, conference materials, dissertations, market research reports" be concluded with ProQuest LLC to the amount of:

- USD 11,490.00 (eleven thousand four hundred and ninety US dollars) based on their BGN equivalent, exclusive of value-added tax, as per the exchange rate quoted by the Bulgarian National Bank on the date of payment under the contract, for a one-year period of use.
